## Annual Report – 2016

Enclosed is the Annual Report 2016 of ARES activities for Escambia County, Florida.

## **Highlights**

- 1. ARES was activated this year for emergency operations for Severe Weather in February – Ferry Pass Tornado.
- 2. Improvements:
  - a. Replace our 800 watts amp with a 1500 watts amp (from the Navy MARS Corry Station equipment acquired last year).
  - b. Added the capability to send digital messages on VHF to the EOC from shelters and hospitals using Winlink via Peer to Peer connection.
    - i. Successfully tested in two exercises in 2016.
    - ii. Only have enough equipment to equip three locations so far in the field (i.e. shelters or hospitals). The EOC and the COOP site at ESAR is also set up for this capability.
    - iii. Added the TNCs to the three hospital jump kits to deploy where needed the most.
    - iv. Adding capability to send digital messages from the shelters to the EOC is a follow up action item from Hurricane Ivan. Used some of the equipment obtained from the Navy MARS Corry Station last year to help fulfil this need.
- 3. Continued making improvements to the ARES stations at the EOC and the COOP site at ESAR as time and resources (people and equipment) allows.
- 4. Confirmed ability to access the Florida Statewide SAR Net via Crestview while awaiting system extension to Milton.
- 5. Regular digital messaging via APRS on ECEN.
- 6. Coordinated with county Communications Supervisors and Emergency Manager regarding antenna changes at the EOC and repeater site.
- Received tasking from county to provide rapid response communications to 16 primary fire stations in event of communications computer outage. Tested comms at 16 fire stations during Simulated Test Exercise.
